**Terms & Conditions Governing Millenia Walk Weekday Bingo Challenge  
6 May 2019 to 30 June 2019**

**Millenia Walk's "Weekday Bingo Challenge"** is organised by Millenia Walk ("MW"). By participating in this Game, you agree to be bounded by these Terms and Conditions, which shall form a valid and binding agreement between you and Millenia Walk.

**Eligibility:**

1. To be eligible for the Game ("Participants"), you must be:
  - a) a Singapore citizen, Singapore Permanent Residents or holders of a valid employment pass or work permit and residing in Singapore
  - b) or a visiting tourist with valid visiting documentation
  - c) aged 18 years and above; and
  - d) have participated in the Game during the Qualifying Period
